Child Abuse – damage to a child for which there is no "reasonable" explanation. It includes non-accidental physical injury, neglect, sexual molestation and emotional abuse.

### **Policy**

The Whitesboro PARD is an organization dedicated to making a difference in the lives of its participants. Our purpose is to educate, inspire and develop the young people of our community. Child abuse is a fact in our society and a matter of critical national concern. It is of special concern to Whitesboro PARD because we provide volunteer role models who greatly influence the development of our children. It is vital that the conduct of all Whitesboro PARD volunteers be beyond reproach. Volunteers must be responsible for using good judgement in their contact with participants. It is the policy of Whitesboro PARD that no volunteer has any inappropriate contact during or after the season with any participant. Any allegation of misconduct or unsuitability of a volunteer will result in immediate suspension as a Whitesboro PARD volunteer pending final disposition. If an investigation determines a violation of this policy occurred, it would result in the immediate and permanent dismissal of the Whitesboro PARD volunteer and referral to the proper authorities.
